Laser process for scaffold fabrication, drug encapsulation and release for tissue engineering. Candidates in the field of Pharmacy and Life sciences are encouraged to apply. We are looking for an enthusiastic Ph.D. candidate to immobilize drugs on polymeric laser-based fabricated scaffolds and to study the interactions of the drugs with cells and scaffolds. Various fabrication techniques for the production of scaffolds will be applied.
